The company has approximately 62,000 employees worldwide at more than 60 locations.

i2S, founded 2001 in Dresden, designs and produces pressure, temperature and mass airflow sensors especially for the sectors automotive, mechanical engineering, measurement and testing technology as well as for other industrial applications. With the acquisition of the company and its approximately 170 skilled employees, Amphenol extends its product range and also regionally enhances the diversification of their activities.
